

Town of Bennett # TB-2019-01-0
Snowmobile Access Ordinance, Amended 2019

The Town Board of The Town of Bennett, Douglas County, State of Wisconsin does ordain as follows:

Section 1 INTENT:

The intent of this ordinance is to provide a means for persons to travel within the limits of the **Town of Bennett, Douglas County, State of Wisconsin.**

Section 2 STATUTORY AUTHORITY:

This ordinance is adopted as authorized under WI statutes 350.18 (3) (a).

Section 3 DESIGNATED ROADWAYS AND/OR HIGHWAYS:

All Town Roads, **Town of Bennett, County of Douglas, State of Wisconsin,** are now open to snowmobile traffic.

Section 4 CONDITIONS:

This ordinance designates the roadways and/or shoulders specified for snowmobile travel by persons traveling within the limits of the **Town of Bennett, Douglas County, State of Wisconsin.** It allows for travel as follows:

1. Snowmobiles are to be operated on the extreme right of the roadway or shoulder and travel with the flow of the traffic.
2. Snowmobiles are to be operated single file.
3. Headlights are to be on at all times.
4. Snowmobile traffic shall yield the right of way to other vehicular traffic and pedestrians.

Section 5 SPEED:

A snowmobile operated on a portion of the roadway or shoulder or a highway pursuant this ordinance shall not exceed **25** miles per hour.

Section 6 ENFORCEMENT:

This ordinance shall be enforced by any law enforcement officer of the **Douglas County, and/or State of Wisconsin.**

Section 7 PENALTIES:

Wisconsin State snowmobile penalties as found in WI statutes 350 11(1)(a) are adopted by reference.

Section 8 SEVERABILITY:

The provisions of this ordinance shall be deemed severable and it is expressly declared that **The Town of Bennett, Douglas County, State of Wisconsin** would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstance is held invalid, the remainder of this ordinance and the application of such provision to other persons or circumstances shall not be affected.

SECTION 9 – TOWN BOARD APPROVAL

The Town Board of the Town of Bennett adopted the Revised Snowmobile Route Ordinance at a meeting held on the 16th day of December, 2019


